

**Diabetes Online Expo 2021****Cooking Masterclass Competition Terms and Conditions**

2. Entry into the competition will be deemed as acceptance of these terms and conditions. Entries must comply with these terms and conditions to be valid.
3. Entry is open to Australian residents only, who are 18 years and over at the time of entry. Anyone connected in any way with helping to set up the competition shall not be permitted to win the competition prizes, including employees of Diabetes Victoria or their family members.
