## **Diabetes Online Expo 2021**

## **Exhibitor Passport Competition Terms and Conditions**

- 1. The Promoter is Diabetes Victoria (ABN 71 005 239 510) whose registered office is at 570 Elizabeth St, Melbourne VIC 3000.
- 2. Entry into the competition will be deemed as acceptance of these terms and conditions. Entries must comply with these terms and conditions to be valid.
- 3. Entry is open to Australian residents only, who are 18 years and over at the time of entry.
- 4. Anyone connected in any way with helping to set up the competition shall not be permitted to win the competition prize/s, including employees of Diabetes Victoria or their family members.
